I served as a Director of the Windsor Fire Protection District and now serve the Sonoma County Fire District since its formation. Our fire districts have struggled for years and as was pointed out in our October meeting our ability to work together is critical for our success. In 2014, I came into being a board member with the understanding the fire service in the way it had been done for decades was no longer adequate for provide for the future. As we all know, that became abundantly clear in 2017.

Since then, consolidations have begun to reform the fire service throughout Sonoma County. Major improvements to our district have been adequate staffing on engines and implementation of provide ALS service on the SCFD engines and EMS transport. Something that could never be achieved if we weren't willing to look to the future. Now we look to help other districts implement such strategies.

In the most recent consolation funding approved by the county, the county would not hear individual cases. They grouped the SCFD/Bodega Bay, Gold Ridge/North Bay and North Sonoma County Fire District into the one funding package. Our negotiations were only successful because we worked together. We all know that most of our districts still do not have adequate funding to provide the services they need to provide. New funding will only be available if we all work together toward one goal.

The county's funds are limited, so we have understood that the most likely way to provide the funding we need is by a fire service tax measure though sales tax. This is a difficult ask as we have seen voters in California repeatedly reject new sales tax measures. To have a chance we must be in lock step with each other. This is also true if we go after any other future funding source.

We have learned that when the Fire Districts Association works together and in unison with the Fire Chiefs association and labor, we are a powerful force.

I am active throughout Sonoma County and regularly attend many events that include Supervisors, city council members, and state government. I have built relationships with many of them. These relationships are essential when our voice needs to be heard.

I look forward to working with each of our member districts to see how the association can further your districts goals. I ask for your support to lead the Sonoma County Fire Districts Association to the future.
