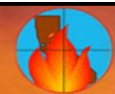

Executive Summary

The FIRESCOPE Board of Directors, Operations Team, Task Force and Specialist/Working Groups continue working to improve the efficiency and effectiveness of the California Fire Service consistent with the organization’s mission. The California Office of Emergency Services (Cal OES) Fire and Rescue Services Advisory Committee / FIRESCOPE Board of Directors has approved and initiated implementation of new or revised FIRESCOPE documents during their January 9, 2019 meeting.

The dissemination and implementation of new or revised policy, procedural and developmental documents is critical to maintaining the integrity and effective execution of Cal OES Fire and Rescue Branch operations, the Incident Command System (ICS), Multi-Agency Coordination System (MACS), and the State’s Master Mutual Aid System. To that end, this “FIRESCOPE Quarterly Briefing” is designed to inform the California Fire Service and affected stakeholders of material changes, and to provide clarity as to the impact associated with new or recently revised FIRESCOPE documents.

Newly Approved FIRESCOPE Material

The following is a list of new or recently revised FIRESCOPE documents with an accompanying summary statement for each item that details the impact to the State’s Master Mutual Aid System, MACS or ICS.

1. **FIRESCOPE ICS 801 Hoist Rescue Guidelines:** Due to the absence of a national helicopter hoist-rescue standard for Public Use agencies, the FIRESCOPE Aviation Operations Specialist Group has developed [FIRESCOPE ICS 801 Hoist Rescue Guidelines](#). The document outlines hoist-rescue equipment standards for aircraft and personnel, pilot and crewmember training standards, pre-planning and operational guidelines for day and night hoist-rescue operations, as well as the source material used in the development of the document.



2. **MACS 400-1 Document Control System & MACS 400-2 Documents and Forms Descriptions:** Both of these guiding documents were revised to update policy related to FIRESCOPE products. Notably, a California mandate requires state government websites, and all documents contained therein, to be fully compliant with the Americans with Disabilities Act (ADA) accessibility standards by July 2019. [MACS 400-1](#) now includes document formatting guidelines to comply with ADA accessibility requirements. [MACS 400-2](#) also revised the FIRESCOPE document numbering system to improve consistency and organization. Importantly, [ICS 900-California Fire Services User’s Guide to Disaster Declarations and Agreements for Cooperation](#) was renumbered to MACS 409. 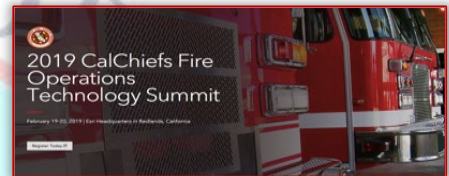


3. **FIRESCOPE MACS 405 Resource Status Report:** The MACS 405 was revised to add a new “OES Equipment” section that indicates the status of Cal OES Engines, Water Tenders, and Other OES resources separate from the Local, State, and Federal Equipment section. The [MACS 405](#) is a form prepared and compiled by the MACS Group Intelligence Section, as information is acquired from Agency Emergency Coordination/Communication Centers. It is used by the MACS Group and the Mutual Aid System to maintain situational awareness, assist in incident prioritization, and inform the System of resource status by area/region or agency, kind and type of requested resources and resources deployed. 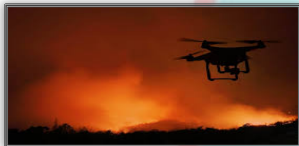
2019 California Fire Service Initiatives

The FIRESCOPE Aviation Operations Specialist Group, overseeing the UAS (Unmanned Aerial System) Working Group, has received extensive interest from multiple agencies to be represented on the UAS Working Group. Some agencies may be asked to work through a City, County or District representative to ensure the Working Group’s Plan of Work and meeting schedule can be managed effectively while representing all agencies.



The FIRESCOPE Website is undergoing a major redesign by Cal OES Staff, which is projected to be rolled out in the summer of 2019. Some new design features include a “one and done” navigation approach, real time updates, and quicker access to the FOG manual, behavioral health resources, and training links to name a few.
